The Town Board of the Town of Lyons met for a workshop on Wed April 4, 2018 at 6:30 p.m. in the Town Board meeting room.

This workshop was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

All stood for the Pledge of Allegiance.

Supervisor Manktelow introduced Mr. Marty Aman from the Wayne County Water and Sewer Authority and Dave Doyle from MRB. Mr. Aman was invited to the workshop to discuss the recent grant the Town received concerning the replacement of lead pipes leading into water customer's homes. The 538 thousand dollar grant was awarded to the Town to reduce the amount of lead that may be in property owners water, Mr. Aman explained that the main source of the lead would be from goose-neck connections to the main. He estimated the cost to replace the goose-neck would be close to \$5,000.00 per unit, so there is only enough money available to do about 100 replacements. He explained that the Town needs to decide how to determine which homes get priority for replacement. One option would be to test water at each home with the highest lead readings getting the priority.

It was suggested that perhaps a couple Board members from Lyons meet with Geneva City officials as that City has also received the same grant, and it is a bit further along in the process and it may have determined how to prioritize the project to which homes. Mr. Doyle sais he would set up the meeting and report back to Supervisor Manktelow.

In addition, the Board discussed the capital charge that appears on the water and sewer bills. Currently, only residents and businesses using water and sewer are seeing the capital charge assessed on bills. Those properties that have no water and sewer service are NOT receiving the capital charge. The Town Board has already passed a resolution stating it would allow the charge to every home, but there were a few properties in question. The Board still believes everyone should be charged the capital charge.

The Town Board also discussed long range water and sewer plans with the former Village as well as possible new water districts outside the former Village.

The Board then discussed the hiring of a new cemetery sexton for both the Lyons Rural and Elmwood cemeteries. The positon, formally held by now Councilman Paliotti became vacant after Mr. Paliotti was elected to the Council. It was decided to advertise for the position and perhaps addition additional duties expected of the newly created part time position.

Councilman D'Amato then moved to approve Amy Kaplan from Rochester as a part time employee for the ambulance department as an ALS tech. Motion seconded by Councilwoman Greco. Vote:

Supervisor Manktelow voting aye

Councilman Paliotti then moved to allow the Supervisor to sign an agreement with New York State Dept. of Transportation to allow the state to do various work at selected sites of the canal trail within the Town

limits, and then allow the Town to retain ownership of the trail. The Town is then responsible be responsible for repair and maintenance of the trail. Motion seconded by Councilwoman Greco. Vote:

As there was no further business, the workshop was adjourned at 8:25 p.m.
