

Dec. 27, 2017

The Town Board of the Town of Lyons met for a meeting on Wed Dec. 27, 2017, at 6:30 p.m. in the Town Board meeting room.

This meeting was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

All stood for the Pledge of Allegiance.

Department reports were heard. Sole Assessor Kayla Sturgill reported that she has completed her course in Data Collection with a final score of 93. All exemption will be mailed out by the first of the year. Also, no upcoming classes are available for her to take at this time. She will update the Board when the next one is available.

Code Enforcement Officer Richard Bogan reported that between Nov. 28 and Dec. 25, 2017, he issued 16 building permits and 17 violation notices. Meanwhile, 19 violations were cleared. He also reported that he attended both the County Planning Board meeting and the Town Planning Board meeting with regard to Local Laws 3 and 4 of 2017 as well as the discussion of a planned development.

Mr. Bogan also provided the Board with an end of year report summarizing what he had accomplished during the calendar year 2017.

Keith Simon reported that the ambulance department responded to a total of 110 calls in Nov.

Also the new ambulance gurney has arrived and the old one sold for \$2,000.00.

In a written report, Highway Supt., Tim Moore reported that the used snow blower was purchased and has been tested. Before the cold and snow settled in, more leaves and brush were picked up.

The water problem on Layton Street has been corrected, as there was ice on the road.

In a written report, Buildings and Grounds Forman Ben Follette reported that leaf pickup has been completed for the year. A couple trees were cut down on Montezuma Street. Other items included Town Office maintenance, ambulance maintenance, truck maintenance, and shop maintenance.
