The Town Board of the Town of Lyons met for a workshop on March 16, 2022 at 5:30 p.m. at the Town Hall.

This workshop was duly noticed by contacting the Times of Wayne newspaper, as well as posting a notice on the Town bulletin board and on the Town's web site.

All stood for the Pledge of Allegiance.

Keith Bridger spoke on behalf of the Lyons Community Center. He is the President of the LCC Board. The Community Center recently donated the building to the Lyons Central School District. In doing so, the school district will be responsible for the maintenance and upkeep of the building. The LCC will remain a private entity and will still be offering the same programs as they currently do. The LCC will need to maintain its liability insurance and salaries. The LCC is requesting additional funding from the Town of Lyons to help with the overhead.

The board discussed the Broadband Service and Lease Agreement. They reviewed a proposal from Finger Lake's Community Broadband Network. This item will be placed on the agenda for the board meeting on March 30th.

The board reviewed additional information that was provided in reference to the Solar Speed Radar sign. This item will be placed on the board meeting agenda for March 30th.

Supervisor Brady gave an update to the board in reference to the Taylor House. He mailed a letter to the owner to bring to his attention that there may be funding available to assist with saving the property as it is a historical building.

Supervisor Brady informed the board of the first Comprehensive Implementation Committee scheduled for March 29th.

Supervisor Brady reviewed the potential need for an amendment to the existing employee handbook in relation to vacation and sick time.

Supervisor Brady informed the board that he has been working with Joan W. on a matching Canal Grant to put fencing, concrete boulders/slabs and a kiosk with signage along the canal down near the little league fields. This item will be placed on the March 30th agenda.

A discussion took place in relation to the Church Clock lights. Currently, the East and West side of the clock have issues with the lighting. Parts for the LED lighting are in and a decision needs to be made as to how to proceed. The board will request more information prior to proceeding.

Supervisor Brady gave the board an update in relation to the Annual Updated Documents.

Supervisor Brady has completed the permit for the Canal Wall behind the firehouse.

A discussion between the board and the Town Attorney was had in reference to town codes. There may be some areas that need revision.
