The Town Board organizational meeting for 2022 was held on Wed. Jan. 5, 2022 in the Town Board room at 6:30 p.m.

All stood for the Pledge of Allegiance.

Supervisor Brady explained that this meeting was called for as a swearing in ceremony along with an organizational meeting.

The honorary Phil DeSain presided over the swearing in ceremony. Parties that were sworn in were as follows: Jim Brady-Town Supervisor, Nancy Collins-Town Justice, Dan LaGasse-Town Councilman, Dan DeWolf-Town Councilman and Amy Shaffer-Town Clerk.

Resolution by Dan LaGasse to appoint John Paliotti to fill the vacancy created on the Town Board for the remaining term expiring 12/31/23 and seconded by Dan DeWolf and carried.

Resolution by Councilwoman Greco-Eddy and seconded by Councilman LaGasse and carried that the Association of Towns annual dues of \$1,200.00 be paid.

Supervisor Brady indicated that the appointment for Clerk to the Supervisor is on hold pending interviews.

Supervisor Brady appointed Dan LaGasse as Deputy Supervisor

Supervisor Brady appointed himself Budget Officer.

Resolution by Councilman Paliotti and seconded by Councilman LaGasse and carried that Amy Shaffer be appointed as Registrar of Vital Records.

Resolution by Councilman DeWolf and seconded by Councilman LaGasse and carried that Tracy Brown be appointed as Town animal control officer.

Resolution of Councilman DeWolf and seconded by Councilman LaGasse and carried that Kayla Sturgill be appointed as sole assessor (APPT. GOOD THROUGH 9/30/2025)

Resolution by Councilman LaGasse and seconded by Councilwoman Greco-Eddy to and carried that the Times of Wayne be designated as the official newspaper.

Resolution by Councilman DeWolf and seconded by Councilwoman Greco-Eddy & carried that the Lyons National Bank be designated as the depository for all Town monies.

Resolution by Councilwoman Greco-Eddy and seconded by Councilman DeWolf & carried that the Town Board authorize Superintendent of Highways Tim Moore, not to exceed \$2,000.00 at each purchase without the approval of the Town Board.

Resolution by Councilman LaGasse and seconded by Councilman Paliotti & carried that the Town Board authorize the ambulance Director of Operations not to exceed \$1000.00 at each purchase without the approval of the Town Board.

Resolution by Councilman DeWolf and seconded by Councilman Paliotti and carried that 58.5 cents per mile be allowed Town officers and employees for the use of their own automobiles in the performance of their official duties.

Resolution by Councilman LaGasse and seconded by Councilwoman Greco-Eddy and carried that Linda Guest be appointed Historian for 2022.

Resolution by Councilman Paliotti and seconded by Councilwoman Greco-Eddy and carried that Villani Law Firm (Katherine Villani) be appointed as town attorney for 2022.

Resolution by Councilwoman Greco-Eddy and seconded by Councilman Paliotti and carried that any Town delegates and/or employees be allowed to attend the Associations of Towns convention in NYC in February, at Town expense.

Resolution by Councilwoman Greco-Eddy and seconded by Councilman Paliotti and carried that the regular monthly meetings of the Town Board be held the last Wed. each month at 6:30 p.m. and the deadline for any business associated with that meeting be the Friday prior to the meeting; and that the Town hold workshops, as needed, on Weds. of each month at 5:30 p.m.

Resolution by Councilman LaGasse and seconded by Councilman DeWolf and carried that Richard Bogan be appointed as the Town's Code Enforcement Officer/ Zoning Officer in 2022.

Resolution by Councilwoman Greco-Eddy and seconded by Councilman Paliotti and carried that Jeff Rios be appointed to the Fire Advisory Board.

Resolution by Councilman Paliotti and seconded by Councilwoman Greco-Eddy and carried that Charlie Taylor be named Town Cemetery Sexton in 2022.
